

Ballots must be turned in at our voting booth before the annual meeting begins at 5:00 p.m.

No voting will take place during the annual meeting. Election results will be announced during the meeting. Every year the Rules Committee reviews the meeting rules and voting procedures to establish ground rules for how to conduct the annual meeting. Procedures are in place for how to vote for director candidates and any new business that may arise. These meeting rules and voting procedures were approved by the Rules Committee on February 13, 2025.

Meeting Rules

- 1. Except as specifically modified below the meeting will be conducted in accordance with ACEC Bylaws, Board Policies #2-18 and #2-27, and the current edition of Roberts Rules of Order, Revised.
- 2. Any speaker must be recognized by the Chair before speaking.
- 3. Only members and duly registered guests will be recognized by the Chair; each person so recognized must give his or her name and show their voting card. Questions and comments should relate to Cooperative matters of general concern to the membership and not the member's particular account.
- **4.** Unless otherwise approved by the Chair, those recognized are to limit their questions and comments to three minutes, with any rebuttal limited to two minutes.
- 5. Questions and comments from members and duly registered guests will be in order during old and new business sessions, and at the conclusion of the officer reports if invited.
- **6.** No resolution affecting Adams-Columbia Electric Cooperative may be submitted by any member unless written copies were received by the Cooperative by February 4th, 2025 in accordance with the prior notification to the membership to permit review by the Rules Committee, and its recommendation to the meeting as to approval or rejection.
- 7. No signs or handouts will be permitted within the building of the place of the meeting, except such handouts as required for the official conduct of the Annual Meeting. Invited Legislators may distribute government issued items such as Highway Maps or similar information. No handouts made available outside of the building will use the name of the Cooperative, its letterhead or logo to imply that the Cooperative supports or opposes any resolution or candidate for director.
- 8. No demonstrations shall be held within the building of the place of the meeting.

Voting Procedures

- Each member present and qualified to vote at the meeting shall be entitled to vote for one candidate for each of the director positions for which a director is to be elected, provided that member has not voted electronically or by absentee ballot prior to the meeting.
- Each member will be given a voting card (one card per membership), which the member should hold up to be recognized or to designate his or her vote as directed by the Chair.
- 3. Once cast, an electronic or absentee vote will not be discarded in favor of another voting method.
- **4.** In the event there is only one nominee who is qualified and willing to run for election for any position, election for that position may be by unanimous consent, by voice vote, or by show of hands or voting card at the meeting.
- 5. Only the Chairperson is authorized to vote electronically on behalf of a corporation, association, board or body politic.
- **6.** With the consent of the Chair, balloting may be closed at the time the meeting is called to order. Counting of absentee ballots may begin prior to the time the meeting is called to order.

General Manager & Board Chair Report

SOLAR UPDATE

We have acquired 14 acres of land adjacent to our Friendship office, the first step in exploring a solar project. Requests for proposals were sent to several contractors, and we have settled on one. Recent administration changes have currently frozen the potential grant fund options. Management is evaluating the financial feasibility of the project. Whether or not we choose to pursue solar, acquiring additional land was prudent as it will allow us to expand our facilities in the future.



NEW SUBSTATIONS

Our engineering team worked diligently to prepare for the construction of two new substations in the coming years. Starting this spring crews will begin construction on our Dixie substation, located in Lincoln Township in Adams County. This substation is expected to be in service this fall. In 2026, crews will begin construction of our new Colburn substation, located along the boundary between Colburn and Big Flats Townships in Adams County. We plan to energize this new substation in the summer of 2027. These substations will support the additional energy needs as well as improve resiliency for several neighboring substations. We have added approximately 400 new services each year over the last six years, driving our need for additional grid infrastructure.

RELIABILITY REMAINS PRIORITY

We continue to provide safe, reliable service for our members, and have placed in the upper quartile when comparing reliability statistics with other utilities. The undergrounding of our distribution system for decades has been a driving force in improved reliability. Not only do we continue to maintain a reliable system for our members, but our transmission company aligns with the same goals and values. American Transmission Company (ATC) will be doing a project in northern Adams County and southwest Portage County. This project includes updating their Saratoga substation along with building a new transmission line to connect the line feeding our Badger West, Arrowhead, and Sherwood substations. These projects will strengthen our system and allow for more flexibility in maintenance and responding to outages.

RATES

After seven years of stable rates for our residential members, it was necessary to make an increase effective January 1st of 2025. Cost-saving measures throughout the co-op and our investment in the West Riverside Energy Center in Beloit helped support us through the economic pressures over the past seven years. Impacts from the pandemic created supply chain issues and increased material costs that unfortunately haven't subsided. Our board of directors and team of employees are always evaluating and looking for opportunities to keep costs in check while maintaining reliability. OPERATION ROUND-UP \$1 MILLION MILESTONE

We'd first like to thank our members who contribute to our Operation Round-Up program each month by rounding up your bill. Your spare change over the years allowed the Operation Round-Up board of directors to award over \$1,000,000 since program inception. Directors met on October 28, 2024, to review applications and surpassed this milestone. We'd like to recognize Nancy Akkerman, Vicki Deltgen, Deb Gerzmehle, Evan Henthorne, John Jarvis, Ellen Kirschbaum, Gale Neef, Kristen Skolarz, Bill Taylor, and all previous Operation Round-Up directors for their efforts in awarding grants to individuals and organizations in our communities over the years.

BRIGHT IDEAS

Our member advisory group shifted to a different style and format last June. To reach more members and learn about what topics members are interested in, we created Bright Ideas. Bright Ideas is an online survey available on the homepage of our website.



FACILITY CHARGE


Your facility charge recovers costs from:

POWER COST ADJUSTMENT (PCA)

This also is factored into our Cost of Purchased Power. These funds contribute to the costs we incur from Alliant Energy, American Transmission Company (ATC), and Midcontinent Independent System Operator (MISO).

COUNTY & STATE TAX

These funds are a direct pass through and go to the counties we serve and the state of Wisconsin.

WI NON-TAXABLE PROGRAM

The money doesn't go into ACEC's accounts. It's split up and passed along to two entities; Focus on Energy and Energy Assistance.

LINEWORKER APPRECIATION DAY

In the quiet hours before dawn breaks, while many of us are still nestled in our beds, lineworkers begin their day, wearing flame-resistant clothing, safety goggles, rubber gloves, and thick, heavy boots. They're the individuals who are the perfect example of dedication to service. Our crews travel across our twelve-county service territory, building, maintaining, and repairing parts of our local system. PEACH COBBLER

PREP TIME - 15 MINS | COOK TIME - 40 MINS

INGREDIENTS

for peaches:

- 5 peaches, peeled, cored, & sliced (about 4 c)
- 3/4 c sugar
- 1/4 tsp salt

for batter:

- 6 Tbsp butter
- 1 c flour
- 1 c sugar
- 2 tsp baking powder
- 1 tsp salt
- 3/4 c milk
- ground cinnamon

April 13 is National Peach Cobbler Day

INSTRUCTIONS

- 1. Add the sliced peaches, sugar, and salt to a saucepan and stir to combine. (If using canned peaches, skip steps 1 & 2 and start at step 3).
- 2. Cook on medium heat for just a few minutes, until the sugar is dissolved and helps to bring out juices from the peaches. Remove from heat and set aside.
- 3. Preheat the oven to 350 degrees. Slice butter into pieces and add to a 9x13 inch baking dish. Place the pan in the oven while it preheats, to allow the butter to melt. Once melted, remove the pan from the oven.
- 4. In a large bowl mix together the flour, sugar, baking powder, and salt. Stir in the milk until combined. Pour the mixture into the pan, over the melted butter and smooth it into an even layer.
- 5. Spoon the peaches and juice over the batter. Sprinkle cinnamon generously over the top.
- 6. Bake at 350 degrees for about 38 40 minutes. Serve warm, with a scoop of ice cream, if desired.
